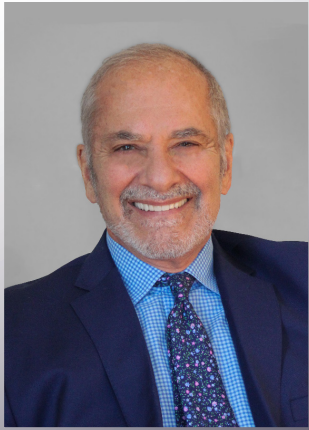

Who we are

The State Legislative Leader Foundation is an independent, nonpartisan, nonprofit organization based in Massachusetts. For nearly 50 years SLLF has served as an impartial educational resource for the men and women who lead America’s state legislatures. The Foundation’s domestic professional development programs, many held in partnership with leading US colleges and universities, focus on critical public policy issues and leadership skills. Our international initiatives in Europe, Asia and the Americas, bring like-minded public officials and business leaders together to learn from one another, share experiences, and build sustainable partnerships. In all this work, domestic and foreign, SLLF enjoys an unmatched reputation for excellence.

What we do

The main focus of all SLLF activities is legislative leadership. We hold that the men and women chosen by their peers to positions of leadership share a responsibility to respect the Constitution and the institutions of our democracy. Our goal is to help these public servants by offering them regular opportunities to participate in educational programs where they can sharpen their leadership skills and better appreciate their responsibilities as stewards of our nation’s state legislatures.

We pride ourselves on being a truly nonpartisan organization. SLLF does not advocate public policy nor do we cater to any special interests. Instead, we strive to be custodians of truth, offering these men and women the chance to meet with their peers to share ideas and discuss the critical issues of the day.

Why we do it

Quite simply, the future of our democracy rests on the health the American state legislature. It’s the day-to-day, often unrecognized work done by state legislatures that makes our unique system of representative democracy the envy of the world and the protector of our basic freedoms.

The cataclysmic events that have thus far shaped the 21st century underscore the essential need for leadership—a quality we equate with integrity, compassion, vision, courage, and common sense.

We make a difference by educating and inspiring our nation’s Speakers of the House, Presidents of the Senate, Majority Leaders, Minority Leaders, and Pro Tempores, to be the best they can be.

How we do it

Each year SLLF convenes a variety of specialized professional development programs for distinct cohorts of legislative leaders and future legislative leaders. While the programs necessarily differ from each other in form and content, all share one common goal—to improve the quality of leadership in our state legislatures.

SLLF programs give these men and women invaluable opportunities to participate with their Republican and Democratic counterparts from across the country in fact-based programs led by distinguished faculties comprised of pre-eminent college professors and recognized national and world authorities. Each program runs for approximately 2 to 3 days during which time legislators, their spouses, and our Advisory Council members, take part in day-long classroom discussions and a variety of social gatherings that further help to establish more permanent bonds of friendship and mutual respect.
